5. RESOLUTION 8 OF 2017: A Resolution to approve financial support for the Benton Chapter of the Bossier Council on Ageing

Mayor Horton explained that the wonderful work of the Bossier Council on Aging has been a success in our community and foresee an increase in attendance. The expected increase of participation will mean a need for an increase of meals. They have asked that the Town contribute up to \$300.00 per month to cover the costs for the additional meals. Mayor Horton also stated that because we are using public funds Attorney Southerland confirmed that it is a legal contribution.

A representative from the Bossier Council on Aging spoke to council about the expected increase in participation and gave the council costs per meal information. Also she announced that they will be offering senior's transportation two days per week for grocery shopping, picking up meds, etc. They will also be opening an hour earlier Monday through Thursday at the Benton chapter.

Council members expressed their gratitude to the Bossier Council on Aging staff for bringing this program to Benton and how it has made a difference in our senior's lives.

Alderman Cathcart asked Bossier Council staff about it being an anticipated need and that the number of participants changes from day to day. He stated that if possible they provide the town with a list of number of meals needed on an "as needed" basis. That way the Town doesn't just pay them \$300.00 every month but only paying for the meals as needed. The Bossier Council Staff agreed.
