A RESOLUTION OF THE MAYOR AND BOARD ALDERMEN OF THE TOWN OF BENTON, LOUISIANA TO FILL THE UNEXPIRED TERM OF ALDERMAN DISTRICT 4 OF THE TOWN OF BENTON

WHEREAS, On August 20, 2019, the Louisiana Secretary of State gave notice of resignation of Honorable Donna Wyatt as Alderman, District 4, Town of Benton, Bossier Parish, and

WHEREAS, the resignation of Honorable Donna Wyatt, whose term had not expired, has caused vacancy of office, effective September 1, 2019, and

WHEREAS, Pursuant to La. R.S. 18:602 2(a), and falling within the guidelines of subsection A, the unexpired term does not exceed eighteen (18) months, which requires no special election.

WHEREAS, the Secretary of State, having given notice to the governing authority, twenty (20) days from the date of resignation to fill the unexpired term of Alderman, District 4, and

NOW THEREFORE BE IT RESOLVED by the Board of Aldermen of the Town of Benton, Louisiana, in regular session convened, do hereby agree that Mr. Leithton Allen is a qualified citizen, and upon motion duly made by Alderman Ron Jones, seconded by Alderman Jackie Carr, and pursuant to the provisions of Louisiana Law, Leithton Allen, be and is hereby appointed to serve in the position of Alderman, District 4 of the Town of Benton, Louisiana.
