Dawn Bushnell asked about the funds budgeted in the Parks and Recreation department and wanted to know what those funds were for. Mayor Horton stated that those funds were dedicated to new lighting and for a storage building requested by the Board of Directors of the Benton Dixie League. Mrs. Bushnell also spoke about the issue with traffic and speeders on Red River during ball season and that we need flashing stop sighs or something that will slow them down. Chief Collier stated that the town can purchase another one of those stationary speed signs that is on 5th street. He explained how it has been very successful in slowing traffic down.
