NEW BUSINESS

Mayor Horton introduced Coach Scott O'Donohue, and Mike McClung of the Benton Middle School Archery Team who have won the World Championship. Coach briefly spoke about the achievements of the Benton Middle School Archery. They have won the North Regionals Championship, 3D State Championship, Bullseye State Championship, National Champions-Bullseye and 3D, and the World Champions 2021-2022. Mayor Horton presented the Proclamation and congratulated the team members and the parents.

Mayor Horton spoke about Ordinance 579 a zoning change that has been approved by the Benton Parish MPC on October 4th and they have made a favorable recommendation to the Council for approval. The application made by Jonathan Hodge requesting a change of zoning classification on .96 acres from R-2 (Multi-Family Residential) to B-1 (Business District) for proposed commercial office building. (Corner of 3rd Street and Pine Street)

Alderman Manning asked the exact location of this property. Mayor Horton explained that is at the corner of Pine Street and 3rd Street. And they plan on constructing a small commercial office complex. A motion by Alderman Jones, seconded by Alderman Manning to set Ordinance 579 for a Public Hearing on November 14th. Mayor Horton asked Mrs. Collier to explain Resolution 14 the 504 Grievance Procedures. Mrs. Collier discussed that this is something we have adopted in the past for application of a LCDBG grant. This is a updated version and this will cover both LCDBG grants that we have applied for this year.

WHEREAS The Louisiana Division of Administration requires that all recipients of Community Development Block Grant funds adopt grievance procedures that provide for the prompt and equitable resolution of complaints concerning equal opportunity and Section 504 of the Rehabilitation Act of 1973, as amended:

NOW, THEREFORE, BE IT RESOLVED that the Town of Benton has adopted an internal grievance procedure providing for prompt and equitable resolution of complaints alleging any action prohibited by the regulation of the U. S. Department of Housing and Urban Development, 24 CFR Part I, implementing Section 504 of the Rehabilitation Act of 1973, as amended (Public Law 93-112). ,Section 504 states, in part: No otherwise qualified handicapped individual. .. shall, solely by reason of his handicap be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance. To further assist those who may have a grievance concerning Section 504 compliance, Stephanie Collier, Town Clerk, has been designated to coordinate the efforts of the Town of Benton to comply with requirements of Section 504 and its implementing regulation, 24 CFR Part 8.

SECTION 504 GRIEVANCE PROCEDURE

The Town of Benton has adopted an internal grievance procedure providing for prompt and equitable resolution of complaints alleging any action prohibited by the regulation of the U. S. Department of Housing and Urban Development, 24 CFR Part I, implementing Section 504 of the Rehabilitation Act of 1973, as amended (Public Law 93-112). Section 504 states, in part: No otherwise qualified handicapped individual . . . shall, solely by reason of his handicap be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance." To further assist those who may have a grievance concerning Section 504 compliance Stephanie Collier has been designated to coordinate the efforts of the Town of Benton to comply with requirements of Section 504 and its implementing regulation, 24 CFR Part 8.

A complaint should be in writing, contain the name and address of the person filing it, and briefly describe the action alleged to be prohibited by the regulation.

A complaint should be filed in the office of the Section 504 Coordinator within a reasonable time after the person filing the complaint became aware of the action alleged to be prohibited by the regulation.

The Compliance Coordinator shall meet with the complainant within 15 days after receipt of the complaint to discuss the complaint and any possible resolution(s).

The Compliance Coordinator or his/her designee shall conduct such investigation of the complaint as may be appropriate to determine its validity. These rules contemplate informal but thorough

investigations, affording all interested persons and their representatives, if any, an opportunity to submit evidence relevant to the complaint.

The Compliance Coordinator shall issue a written decision determining the validity of the complaint no later than thirty (30) days after its filing. The response will offer options for resolution of the complaint. The Town of Benton shall be advised of any decision or resolution regarding the complaint.

If the decision of the Compliance Coordinator does not resolve the issue, the complainant may appeal the decision of the coordinator within fifteen (15) days after receipt of the response to the Mayor of Benton or his or her designee.

The Mayor of Benton or his or her designee shall meet with the complainant within 15 days after receipt of the appeal to discuss the complaint and any possible resolution. Within fifteen (15) days after the meeting the Mayor of Benton or his or her designee will respond in writing, with a final resolution of the complaint.

The Section 504 Coordinator shall maintain the files and records of the Town of Benton relating to complaints filed hereunder.

The right of a person to prompt and equitable resolution of the complaint filed hereunder shall not be impaired by the person's pursuit of other remedies such as the filing of a Section 504 complaint with the Department of Housing and Urban Development or other Federal or State Agencies. Utilization of this grievance procedure is not a prerequisite to the pursuit of other remedies. Complaints may be forwarded for disposition to the:

Determinations made under these procedures shall be liberally constructed to protect the substantial rights of interested persons, to meet appropriate due process standards and to assure the compliance of the Town of Benton with Section 504 and its implementing regulation.
